Update from Forest Practices Board

Representatives from the Forest Practices Board provided directors with an update on their organization's activities. The Forest Practices Board serves as the independent watchdog for sound forest and range practices in BC. They provide reports to the public and government about compliance with the Forest & Range Practices Act and the Wildfire Act. They respond to concerns from the public and provide information about forest and range practices and processes. They can also act as a go-between to connect local governments with forest and range licensees and/or government staff to address issues.

Board supports call for helicopter-assisted search and rescue

The Regional District will be providing a letter of support for Prince George Search and Rescue's efforts to create a regional helicopter external transportation systems (HETS) team. HETS allows search and rescue teams to move people and equipment into normally inaccessible terrain. This technique is used to lower rescuers into areas where tall trees prevent the helicopter from landing or allowing search and rescue members to hover exit. It is also used to rescue people in high, glaciated and mountainous terrain.
