Addendum No. 2 is being provided in clarification to ITT CS-19-11 released October 2, 2019.

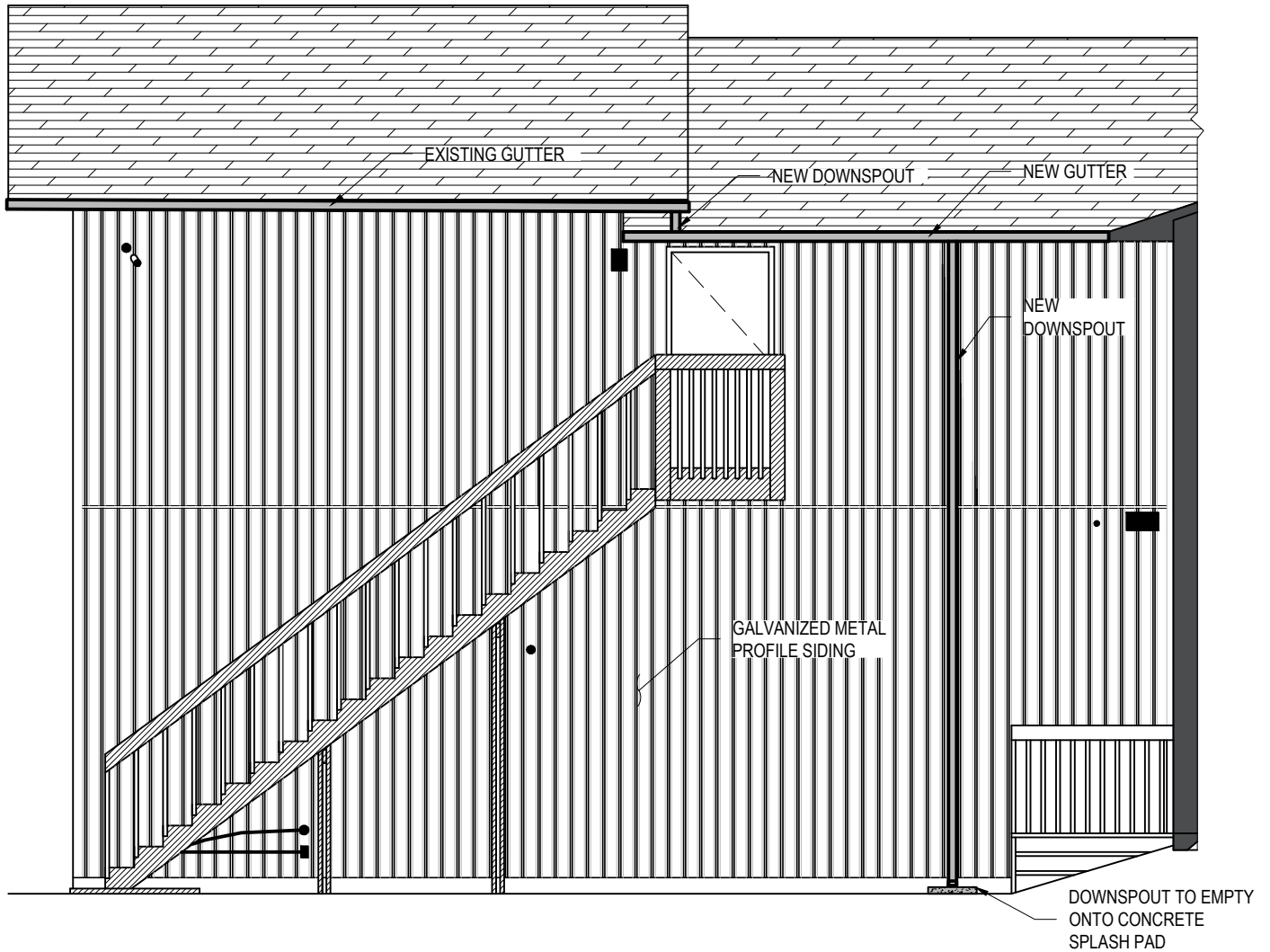
Please see the attached drawing showing the new gutter and downspout assembly on the partial North wall of the Shell-Glen Fire Hall.
